Through the experience gained in the various contexts of activity, university and CNR, but also in the dialogue with other Departments and disciplines, with decision-making and organizational organizations, national and international, as well as with sectors of civil society and the productive world, I was able to ascertain that the greatest challenge for the social sciences consists in pursuing an ever higher methodological rigor and scientific accuracy in the research activity but, at the same time, being able to respond flexibly to requests for concrete solutions to real problems and major challenges of contemporary society from other areas of scientific research, from the country's production sector and from civil society. In this way, listening to the needs of society and monitoring the evolution of the social, economic and legal dynamics and systems of the international community and of the country, a constant tension is ensured towards the identification of frontier social research and the overcoming of borders of traditional research.
